





THE CHALLENGE

From Baseline to Best

Escalate Consulting had a traditional baseline for security. However, they were missing an overarching framework to keep them accountable, help them prioritise measures, and take their cyber security posture to the next level.



As an existing Managed IT client, it was a natural choice to migrate to ADITS'

CyberShield solution - an all-in-one cyber security solution built around Managed IT, essential security controls outlined by the SMB1001:2025, and IT governance.

Unlike other frameworks that may focus solely on technological solutions or specific aspects of cyber security, CyberShield and SMB1001 adopt a comprehensive, holistic approach. They focus on people, processes, and technology to create a robust and resilient cyber security posture.

SMB1001 is a multi-tiered cyber security standard, supported by Dynamic Standards International (DSI), that closely aligns with ADITS' goal to make cyber security more accessible and less costly for small and medium-sized businesses (SMBs).

Striving for Excellence

The uplift project commenced with an analysis of the threat landscape in which Escalate Consulting operates, their growth plan for the coming years, and discussions with the team about their risk tolerance. ADITS also conducted a thorough assessment of the existing tools and security measures. This helped outline the path to align with SMB1001:2025 and uplift to CyberShield.



TECHNOLOGY MANAGEMENT

To enhance threat detection, a firewall and Sophos MDR were installed, and operating systems were patched to fix vulnerabilities. Microsoft 365's licences were also upgraded to Business Premium to unlock enhanced security features. Additionally, their comprehensive backup strategy was refined to protect important digital assets.



POLICIES & PROCESSES

Existing policies were reviewed and optimised. New ones were implemented for invoice fraud prevention and for maintaining a visitor register. Confidentiality agreements were drawn up for all employees.



ACCESS & PASSWORD MANAGEMENT

Other key pillars of CyberShield include access and password management. For this, ADITS partners with Keeper, an Enterprise Grade Password Manager that generates and securely stores strong, unique passwords.



CYBER AWARENESS TRAINING

With 30% of data breaches in Australia attributed to human error, such as falling for phishing attacks or mishandling sensitive information, ADITS understands the criticality of security awareness and training. CyberShield includes
